# How to invoice Green Energy Trading if you are a GST registered system owner

#### Introduction

Congratulations on your decision to install renewable energy generation or energy efficient products in your business. We expect you will enjoy substantial environmental and financial benefits for many years to come.

To encourage businesses, like yours, to make sustainable choices, the federal, Victorian and New South Wales governments administer environmental schemes. These schemes enable businesses and individuals to access a financial benefit and reduce the upfront cost of their installation. The financial benefit (which comes in the form of environmental certificates) is calculated based on the amount of energy the new system will generate – or save – over the life of the asset.

Since 2007, Green Energy Trading has been helping businesses unlock the value of these initiatives by facilitating the somewhat complicated process of environmental certificate creation. It is on this basis that we ask for your assistance now, to ensure that the GST requirements associated with your purchase are handled in a compliant way.

### **GST** treatment

The correct treatment of GST on environmental certificate supplies is easy to understand when the following principle is understood:

In a standard installation, there are two separate and distinct transactions taking place:

- Your supplier is selling the PV, hot water, heating or lighting system to your business; and
- Your business is selling the right to create environmental certificates to *Green Energy Trading* (the registered agent) enabling you to access the financial benefit.

Commonly, your supplier will deduct the value of the environmental certificates from your invoice to reduce your upfront cost. Though often known as a 'point of sale discount', this is actually just another form of payment from your business to the system supplier, facilitated by Green Energy Trading.

It is for this reason that we require a tax invoice from your business for the GST-inclusive value of the certificates, as advised by your system supplier.

The Australian Tax Office considers your sale of the right to create environmental certificates to be a taxable supply, and will expect you to remit 1/11<sup>th</sup> of the total in your Business Activity Statement. Don't worry, your system supplier will reduce your price by the GST-inclusive amount of this invoice to ensure you are not out of pocket.

Where the system owner (i.e. your business) is registered for GST, Green Energy Trading is unable to create and purchase environmental certificates until your tax invoice is received.

# Tax invoice requirements

Your tax invoice should:

meet the standard tax invoice requirements of the Australian Taxation Office.

- clearly state that payment is to be made to your system supplier (you have already been 'paid' for this invoice, via an upfront deduction on your system purchase).

We are unable to provide the trade references or Director's guarantees which are often requested in a *trading* account application.
